- Information and awareness of contractors and service providers about the procedures to be put in place by requiring their application;
- Continuous commitment to planning and implementing all necessary actions to prevent and minimize environmental impacts (emissions, consumption and use of raw materials);
- Containment in the production of waste, promoting, where possible, its recycling;
- Facilitating and promoting the separate collection of waste;
- Minimize the possibility of soil pollution through spills and spreading;
- To this end, the Corporate Management defines tasks, roles and responsibilities for carrying out environmental monitoring in order to:
  - o Measure any impact phenomena caused by company activities by activating appropriate corrective actions;
  - Verify the effectiveness of actions to address and resolve any residual impacts;
- Plan supervision and control activities to:
  - o Verify the correct application of the procedures of the Integrated Management System;
  - o Identify any deficiencies and suggest appropriate corrective actions;
  - Evaluate the effectiveness of actions prepared to ensure adequate protection of the environment; Evaluate periodically, at least annually, the achievement of protection objectives by identifying room for improvement, consequently redefining the objectives, criteria and actions to prevent and minimize impacts;
  - o Evaluate new technologies with lower environmental impact and pursue their application in relation to sustainability:
  - o Ensure compliance with the contractual compliance signed by the Enterprise.

#### *1.3.* SAFETY

- Minimization of risks and improvement of safety conditions in working environments;
- Provision of adequate infrastructure and individual preventive and protective equipment;
- Training/informing/awareness-raising of personnel on compliance with the company's safety regulations on sites;
